SirsiDynix Acquisition by Vista Equity Partners Now Complete

Leading Software Provider to Libraries Remains Dedicated to Innovation, Customer Service

HUNTSVILLE, Ala., Jan. 17, 2007 – SirsiDynix, the global leader in strategic technology solutions for libraries, announced today the completion of its acquisition by Vista Equity Partners, a \$1 billion private equity firm focused solely on investing in software and technology-enabled businesses.

SirsiDynix announced on Dec. 27, 2006, that it had signed a definitive agreement to be acquired by Vista. Under terms of the agreement, Vista becomes the sole institutional investor in SirsiDynix. Further financial details were not released.
