The requirements of FedRAMP are designed to comply with the Federal Information Security Management Act of 2002 (FISMA), an act passed in recognition of the importance of and need for increased information security among U.S. government agencies.

SirsiDynix currently leads the industry in its pursuit of FedRAMP. The SirsiDynix SaaS offering includes options for use of a data processing facility which is already FedRAMP-certified. The only remaining requirement is to add certain features to the EOS.Web software. Guiding the progress to FedRAMP compliance is the SirsiDynix Information Security Officer, a former FISMA auditor for the Department of Defense (DoD). As part of the path to compliance SirsiDynix has already obtained TRUSTe Seal, as well as accreditation to the FISMA and ISO 27001 standards. Additionally, SirsiDynix provides its libraries with 24/7 critical care line for support anytime and responsive resolutions.
